When to use this form

Use this form to instruct an employer to pay super contributions into an AMP super account.

Note: To find out if you can choose your own super fund, or for further information on choosing your choice of super fund, visit ato.gov.au.

Contribution types:

- Super guarantee (SG) and award
 Contributions an employer pays to comply with an
 Award or Industrial Arrangement.
- Salary sacrifice and additional employer
 Contributions paid from an employee's pre-tax salary, and any contributions an employer wants to make for an employee in addition to SG, Award/Industrial
 Arrangement and salary sacrifice contributions.
- Member

Contributions paid from an employee's after-tax income.

Employees – what you need to do

- 1. Complete the enclosed choice of super fund form.
- 2. Provide your employer with the completed **choice of super fund** form, along with this information sheet.
- 3. To ensure your super contributions are being paid into your account by your employer or to check your contributions/ account details—simply log in to your account at amp.com.au today.

Note: It may take up to four months for your employer to pay your first contribution into your nominated super account.

Employers – what you need to do

You have received this form because your employee has chosen to have their super contributions paid to an AMP complying super fund.

Chosen fund payment methods

Under SuperStream, you need to pay super contributions using an industry approved electronic payment method and include the relevant data with your payment. For more information go to **ato.gov.au/super/superstream**.

- Payroll provider or clearing house

If you have 19 or less employees, you can pay your employee contributions through the Small Business Superannuation Clearing House—a free online clearing house service provided by the Australian Government to assist small businesses in meeting their super guarantee obligations. Payroll provider or clearing house

You can use a payroll provider or clearing house that offers a SuperStream compliant payment method. Your payroll provider or clearing house can confirm whether they're certified and comply with SuperStream.
