The Fund produced a very strong return for the December quarter as domestic property markets continued to surge.

Market Review

Australian listed property had a very strong March quarter, outperforming broader Australian shares. Goodman Group, the largest individual stock in the index, was the key driver of the outperformance following its inclusion into the global FTSE EPRA NAREIT index on 18 March.

Outlook

We believe the Australian listed property sector will continue to be supported by stable income streams over the long-term, though we expect further volatility is likely in the current inflation and interest rate-focussed environment.
