Fund Performance

The Investment Option produced a negative return for the December quarter, as domestic property markets pulled back from their recent highs. Stepping back to a one-year timeframe however, performance was extremely strong, as listed property markets have surged along with broader shares.

Market Review

Australian listed property followed global peers lower for the December quarter, driven by less rate cuts being priced in for 2025 overseas.

Outlook

We believe the Australian listed property sector will continue to be supported by stable income streams over the long-term, though we expect further volatility is likely in the current inflation and interest rate-focussed environment.
