

# **Secure Growth Plus**

Quarterly Investment Option Update

31 December 2024

### **Aim and Strategy**

To provide returns which exceed inflation over the longer term, but with lower variability of returns than would be expected from an investment option with the same exposure to bonds, cash, shares and property. The investment strategy is to invest in a diversified portfolio with a core of cash and bonds with exposure to shares and property to enhance returns. Changes to investment allocations, including the use of derivatives, can be made according to the outlook for the various investment sectors and the nature of the investment. This is a crediting rate investment option.

#### **Investment Option & Market Commentary**

Aggregate returns on the underlying investment portfolios performed broadly in line with expected levels over the quarter, driven mainly by increases in the values of global equity holdings. Medium to long-term bond yields in Australia increased by 30-40bps, while the official cash rate remained unchanged.

The table below sets out the net crediting rates (after tax and before fees) that applied at the start of the last four quarters.
